

FEE SCHEDULE

FEES AND CHARGES. The following fees and charges may be assessed against your account:

Check printing fees vary by the style of check ordered.

An overdraft fee of \$35.00 will be charged per item for covering overdrafts created by check or draft, in-person withdrawal, or other electronic means.

A chargeable debit fee of \$.25 will be charged for each debit transaction (withdrawal, check paid, automatic transfer, internet transfer, Bill Payer debit, or payment out of this account, excluding ATM/Debit card withdrawal and point of sale purchases) in excess of 200 during a statement cycle. This fee will apply if the average daily balance falls below \$300.00 during the statement cycle. A return (RTN) item fee of \$35.00 will be charged per item for non-sufficient funds created by check, in-person withdrawal, or other electronic means.

An account closing fee of \$25.00 may be assessed if account is closed prior to 90 days of opening.

A paper statement fee of \$4.00 per statement will be assessed unless the account is set up for electronic statement delivery via online banking. (e-statements)

Some fees may be subject to state sales or local option tax.
